The Department of Public Works is requesting the Legislature's approval of a contract amendment in the amount of \$27,291.40 with Gallo Construction Corp. for labor and materials associated with the installation of additional security fencing and paving work at the new Coeymans Highway Garage Facility. The original contract total was \$3,411,285.00, this amendment brings Gallo's contract total to \$3,438,576.40. The overall project budget for all contracts associated with the new Coeymans Highway Garage Facility is under budget by \$103,702.65. This amount takes into account the additional \$27,291.40 being requested in this contract amendment.
