DESCRIPTION OF REQUEST: (state briefly why legislative action is requested)

We are requesting permission to enter into a contract with the New York State Office for Prevention of Domestic Violence (OPDV) and accept grant funding in the amount of \$138,428. This is an extension of the existing Enough is Enough grant contract, covering May 1, 2025 - April 30, 2026. This funding will allow CVSVC to continue partnering with colleges and universities in Albany County to provide prevention activities and direct victim services to students and employees. These funds are accounted for in the 2025 budget and will be used toward already-budgeted staff salaries, fringe, client database subscription, staff travel and training, CVSVC space costs, and printing of brochures, flyers, and informational materials for clients.
