DESCRIPTION OF REQUEST: (state briefly why legislative action is requested)

The Albany County Public Defender's Office requests authorization for Aid To Defense Program grant contracts with the NYS Division of Criminal Justice Services, with terms of October 1, 2018 through September 30, 2019, October 1, 2019 through September 30, 2020, and October 1, 2020 through March 31, 2021. The grants provide salary support for attorney, investigator, and support staff positions in the Office's criminal defense division, with a total funding amount of \$108,077 over the grant terms. Of this amount, a total of \$86,708 has been received by the County for the time period of October 1, 2020 and \$21,369 will be claimed for the time period of October 1, 2020 through March 31, 2021.
