Re: Proposed improvements at Roger Keenholts Park, Town of Guilderland

Dear Acting Commissioner Robert,

In response to Albany County's letter dated August 8, 2024, the Town of Guilderland is pleased to submit this request for financial assistance in the amount of \$19,000, under Albany County Improvement Initiative (Resolution No. 448), for improvements to girls' softball fields at Roger Keenholts Park, 6335 French's Mill Road, in Guilderland Center.

Executive Summary

Roger Keenholts Park, a 55-acre park, was added to the Town's park system in 1993 in response to the growing need for additional ballfields. The park is named in honor of Roger Keenholts, a former historian for the Town of Guilderland and the Village of Altamont. The park is the home for <u>Guilderland Baseball</u> (Cal Ripken, Babe Ruth, and Travel) and <u>Guilderland Girls Softball League</u> (Rec and Travel), which serve children in first grade through twelfth grade in Guilderland, Altamont, and Voorheesville.

The park has five girls' softball fields, eight boys' baseball fields, and a state-of-the-art Babe Ruth level baseball field, known as Dutchmen Field. Each area also has enclosed batting cages, concession stands, and covered pavilions. Dutchmen Field has stadium seating, a large scoreboard, and lights for night games. One of the other boys' baseball fields are lighted. There are no lights on any of the girls' softball fields.

Both the baseball and softball programs are managed by volunteers who coordinate the scheduling of games, field usage, park maintenance, and concession. Town Parks & Recreation staff are now working with volunteers and supporters of girls' softball to upgrade the fields by adding significant enhancements for players, families and friends watching softball games. The long-term goal is creating a flagship girls' softball field with lights, improved seating, enhanced batting cages, and heightened fences.

The County's park improvement grant will advance the Town's short-term goals and immediate needs for offering a safer environment for softball players, spectators, and park users, and offer a more enjoyable experience. The project includes installing protective netting on softball fields to protect spectators, often families with young children and passersby from errant balls and bats, and replacing spectator seating with secure and new seats.

The project's anticipated cost is \$26,143.96, of which \$19,000 is requested under the County grant program. The project's remaining cost of \$7,143.96 will be funded by the Town's Park Improvement Reserve. We greatly appreciate the County's consideration of this request.

Project Expenses

A breakdown of project's costs of \$26,143.96 is provided in the vendor quotes attached to this letter, including \$23,599.96 for four rows of 15-foot length bleachers and \$2,544.00 for protective nettings for each softball field.

Benefits Statement

In response to the increasing demand for team sport facilities, the Town has dedicated significant resources to provide for a safe environment for players and spectators. The Town is also committed to seeking parity in its facilities for boys' and girls' sports. An important part of this concerted effort is elevating the playing experience for girls' softball teams to the same level as boys' baseball teams.

In the attached letters of support, Parks & Rec Director CJ Gallup and Guilderland Girls Softball's Board President Thomas Kachadurian explain how the proposed improvements will advance this goal, with the installation of high-quality netting that protects spectators and persons walking by from being struck by batted or thrown softballs, or errant bats. The improved spectator experience includes new seating consisting of four rows of bleachers. This project will provide safer facilities for girls' softball, families, friends, and spectators.

Financial Assistance Need/Matching Funds Availability

The need for assistance for the proposed project is demonstrated by the fact that the equipment and systems proposed for installation are not included in the current budget of the Guilderland Parks and Recreation Department. The provision of an Albany County grant in the amount of \$19,000 will allow the proposed project to move forward. Any funding in excess of the amount of the Albany County grant that is necessary to complete the proposed project will be made available from reserve funds of the Town of Guilderland.




