## **Justification**: (state briefly why legislative action is requested)

The Albany County ARPA Executive Committee is requesting authorization to award funding to the Capital Region Workforce Development Board for the provision of On-the-Job training funding in Albany County. The Executive Committee approved the provision of \$1,000,000 in ARPA funding on June, 2, 2023. The Workforce Development Board currently runs an On-the-Job training program in Albany County that provides companies with a 50 percent match for training that they provide to new or existing workers. The intent of this contract is to utilize ARPA funding to supplement the existing program and provide additional training opportunities in Albany County to support our companies and workforce. Funding will help companies address challenges they face in hiring individuals with needed skills while simultaneously providing workers with the skills they need to succeed in today's economy. The Workforce Development Board will be administering this program on the County's behalf and therefore will be considered a subrecipient of County ARPA funds. Up to 10 percent of the award may be utilized for administrative costs.
