Re: Budget Amendment - Emergency Contract

Dear Mr. Joyce

The Albany County Water Purification District (District) is requesting approval of a budget amendment for the transfer of \$300,000 from the District's Fund Balance to the Equipment Repair Line to pay for an emergency repair of a high voltage switch. The high voltage switch is a critical component as it supplies power to the North Plant's Preliminary Treatment Building and influent pumps. A summary of the transfer request is as follows:

## Overtime Transfer:

Decrease Fund Balance : \$ 300,000 Increase Equipment Repair Line (8130.4.4070) \$ 300,000

The insulation on the switch's main electrical feeders to the adjacent transformer were worn causing electricity to arc across the feeders resulting in the switch to fail. High Voltage Electric Service was contracted to replace the 15kv switch based on the age of the switch and damage done.
