

Park Information

The Town of Westerlo Veterans Memorial Park is located on the south end of the Hamlet of Westerlo on County Route 401, north of the main tributary of the Basic Creek. The park features a large pavilion with picnic tables, barbecue area, electricity, public restrooms and water hookup

Recreation: Recreational activities in the park include fishing, hiking trails with geocaches, snowmobile trails, basketball court, large playground, 2 tennis courts, a little league baseball diamond with concession stand, and one practice backstop. There is a volleyball net, adolescent sized play equipment, and horseshoe pits for party goers as well. The park is open daily until 10 pm and can be rented, for a fee, by both Town residents and nonresidents.

Activities: The BKW Little League calls the park their home and is often busy with Little League games throughout the season. The Westerlo Veterans Memorial Park plays host to a number of local events held in the park. These events are sponsored by the Town of Westerlo, Town of Westerlo Volunteer Fire Company and various local organization. The park is also busy with residents of Albany County renting the park for weddings, showers, birthdays, graduations, family reunions and other private events.

Park Projects Summary

In 2023 the Town of Westerlo established a Citizens Committee for Park Improvement. The committee has met regularly to identify items in Veterans Memorial Park and Blaisdell White Memorial Park that are in need of repair, replacement, updating and items to be added to both parks.

As a result of the committee, over 50 items/projects have been identified and presented to the Town Board. The committee also works together with the Highway Department who oversees the park employees. With the approvals from the Town Board and cooperation with the Highway Department over half of the identified items have been addressed. Among those completed items are: addressing a trip hazard around a pavilion, trimmed branches around a pavilion, removal of old, rusty and non-functional BBQ grills, relocate porta potty to a more discreet and safer place, remove old, rusty posts no longer in use, purchased new child and toddler swing set and slide, handicap swing, wheelchair swing, basketball nets, volleyball nets, removed broken and unsafe playground toy, remove and replace old garbage bins, added recycling bins, removed old, broken, unsightly and outdated fencing, removed overgrown shrubbery, replaced basketball backboards and fenced in the basketball court, purchased new tennis court posts and net and added pickleball posts and net, purchased soccer goals and chalk line and purchased one set of bleachers (out of 4 needed)

In addition, the committee decided to get the community involved and vested in their parks and hosted Community Park Clean Up Day in June 2024. The June day was a success with volunteers tackling most of the painting that needed to be done in Blaisdell White Memorial Park. Additional Community Park Clean Up Days will be scheduled for the spring and summer of 2025.

Many items on the identified list still remain. Some of those items are tasks that require the Town Highway Department labor, such as replacing wire protection on dugouts, replacing doors on a storage building, installing signage, adding appropriate mulch for playground areas.

All improvements will conform to any state, local and town codes as well as the safety guidance provided by insurance provider.

Park Projects - Benefits

Tennis and Pickleball Courts

- Addresses the need to repave the courts for safety reasons. Courts currently have deep and wide cracks
 that make it hazardous for play. Court has since been closed until it can be repaired.
- Addresses numerous community requests for updating of tennis courts and adding a pickle ball court.

Basketball Fences

- Fenced in basketball courts will keep children and adult players safe from chasing balls into parking lots, oncoming cars and the Basic Creek.
- Will encourage more players to have an updated, well kept and safe place to play.

Bleachers

Safe sturdy seating for all spectators at all baseball fields. Will encourage more attendance and participation in Little League. The beautification and upgrades to the parks will also encourage the growth of the Little League programs.

Town Hall Playground

 Safe fenced in playground for families with children who have disabilities to run freely in a confined, safe space without fear of running into the parking lot, road or Basic Creek.

Overall

Repair/replacement/upgrading/additions to both parks serve not only the residents of Westerlo but also
those in neighboring in Towns in Albany County who often use the parks for recreation or secure them for
private parties.

Project Need for Assistance ~ Grant Request - \$19,000.00

Westerlo is a small rural community with just over three thousand residents. The operating budget is small compared to other towns and cities in Albany County. Most of the square footage of the Town is rural land or farmland. There are only a handful of businesses with Hannay Reels being the largest. The tax base does not boast a large revenue stream of real property taxes. Therefore, with rising costs and the need to keep expenses at a minimum for tax payers it is necessary to seek alternative methods of securing revenue.

Veterans Memorial Park is usually reserved every single weekend from Spring to Fall and sometimes week nights. Residents enjoy weddings, showers, birthdays, graduations etc. in our pavilion and make use of the other facilities available for their guests, such as the playground, volleyball, horseshoes, tennis and the basketball court.

Since Veterans Memorial Park is the most used park in Westerlo, the best use of the Albany County Municipal Park Improvement Initiative Grant would be to repave and restripe our tennis court and repurpose one court into a pickleball court. The condition of the courts is currently hazardous and poses a safety risk to residents. The court has established large cracks, grooves, buckling, faded markings and damaged/old nets. We have shut down the courts to public use until they can be repaired. There has been a growing, vocal interest from Westerlo and surrounding Towns for the establishment of a pickleball court. Pickleball appeals to all ages and abilities. It is a low impact activity very suitable for older adults who are in need of staying active. The sport's also a very affordable sport in a time where everything is so costly. Offering this activity to our community will help promote an active an healthy lifestyle for young and old alike. Further, it may enhance an interest in other activities and amenities the park has to offer. The Town of Westerlo has already purchased new posts and nets and is on board to fund the remainder of the cost for repaving and restriping the court.

Cost to re-pave and stripe two courts in Veterans Memorial Park is \$50,310.
