Justification: (state briefly why legislative action is requested)

Local Social Service districts are required to provide emergency/transitional shelter to homeless individuals and families. Therefore, permission is requested to contract with IPH to operate Mercy House located at 12 St. Joseph's Terrace in Albany. The facility will serve 6 adult females and 14 adult males.

IPH has taken over operation of Mercy House, which was previously run by Catholic Charities and closed in 2022. Note that as an exception to the Request for Bid policy Social Services is allowed to contract with all willing and able providers in accordance with Albany County Purchasing procedures.

The provider will assist residents in applying for Temporary Assistance, SSI/SSD and other benefits which may assist them in reducing barriers to homelessness, helps them to address other factors that underlie their homelessness and secure permanent housing or appropriate residential placement; the development of an Independent Living Plan (ILP) which, at a minimum, includes assessment of needs related to housing permanency and linkage to services designed to address the factors which underlie homelessness, assistance in securing permanent housing and/or residential placement. The shelter provides three meals a day for residents.
