The Department of Mental Health requests permission to enter into a contract in 2023 with Senior Hope Counseling for the provision of medically supervised outpatient treatment to Albany County citizens age 50 and older with substance abuse and narcotic addiction related issues. NYS Office of Addiction Services and Supports (OASAS) shall provide pass through funding to Senior Hope through Albany County Department of Mental Health in the amount of \$245,755. This appropriation is anticipated in the 2023 budget. There is no County share associated with this contract.
