Respectfully request a resolution authorizing the County Executive to enter into an Agreement with the New York State Governor's Traffic Safety Committee in the amount of \$570,977.00 for the 2022 Albany County STOP-DWI Plan. This grant will be utilized to fund enforcement efforts and DWI supplies for all participating Albany County municipal police agencies, staffing for the STOP-DWI Program staff, partial salaries for staff with contracted agencies and education/awareness programs and campaigns.

Please note that the STOP-DWI Plan covers the dates of October 1, 2021 – September 30, 2022, but the County Contracts that are included in this plan cover the dates January 1, 2022 – December 31, 2022.
