We operate onsite early childhood, after school, camp, fitness, aquatics, seniors, cultural and meals programs.

Is this a new project or expansion of an existing initiative, please describe.

This is an expansion of an existing initiative through the renovation of the JCC indoor, Betty Clark pool, an existing

facility of the JCC. The pool was forced to close in January, 2023 due to sustained, uncontrolled leaking, and has spent the last year seeking funds for its renovation. The JCC has good experience with the management of and programming for such a facility, and once the pool renovation is completed, will reopen for the community.

Please provide an executive summary of the proposed program or project for which you are requesting funds. Include a description of the target population, as well as the goals and objectives of your proposed project (500 words or less).

This project, entitled "Saving the Betty Clark Pool" will repair the JCC's indoor pool that has been out of commission for JCC and community use for one year at the time of this application's submission. The repairs include replacing the pool's main drain with a Federally-compliant set of twin main drains, replacing support beams of the pool deck, repairing the pools gutter system, installing new piping from the gutters to the pool pump room, repairing the pool deck drains and installing new piping from them, and repairing approximately 10-15% of the pool decks concrete structure. Additional re-tiling work, and subject to funding, replacement of the pool filter is also anticipated.

The target population includes JCC members for whom many, including senior adults, utilize the pool as primary sources of exercise in the form of lap swimming and training. A second target population, both members and not, are families with children who utilize the pool for recreations and swim classes. A third population are adults who utilize the pool for fitness classes that are water-bound, including aqua-exercise.

Other populations provided with swim time are early childhood children and afterschool children, the JCC's swim team, and teens and adults taking aqua-safety programs (lifeguarding and WSI).

The pool went down just as people were returning to in-person exercising at the JCC, particularly aquatics programs and lap swimming by senior adults They were the last to return to the JCC for in-person activities (and other agencies) and felt that such exercise provided a safer physical environment for exercise. So as a matter of building a resilient and active community, the pool with year-round swimming and exercise is a large element of a healthy neighborhood and community, especially true for senior adults but also for all ages

Our goal is to complete the project by March/April 2024 and restart all indoor aquatics programs at the JCC.

Please explain why this program or project is needed within the County.

There is a dearth of publicly accessible indoor swimming pools in the vicinity of the JCC. Other such pools so colocated are part of the Albany City school system or in private schools and colleges. In both cases, access is rarely if ever available.

With its policy and practice of being open to the entire community, the JCC provides opportunities for aquatics programs for an entire day, seven days a week. The accumulated experience and expertise of running such a community pool for 60 years also optimizes the pool's use for its variety of users and programs.

The anticipated closing of St. Rose removes one private indoor pool that was open for limited public use, primarily through their Saturday Excel program for 9-12 year olds. The JCC has begun conversations to pick up that program.

All funded activities must meet the objective of responding to the public health and negative economic impact of the pandemic. Please describe how your proposal will help address this objective and assist with recovery (250 words or less).

Users of the pool perceived it as a safe return to physical activity, given the more extended distance between each user and the elevated sanitary environment a pool provides with chlorination. They were thus less anxious and more willing to return to physical exercise in such a manner, and this was most true of senior adults. There is also the social element associated with swimming: that which brings them to the JCC has a corollary effect of their staying at the JCC in spaces reserved for senior adult use for additional social and recreational activity, and so combatting the loneliness that the Covid period fostered.

Economically, JCC membership numbers plummeted by half from pre-pandemic numbers to the end of 2021. In 2022 we saw a slight rise is membership and overall numbers of participation, especially in childcare. But with the closing of the pool for 2023 we saw a drop in membership again, while other program participation continued to rise, including other non-aquatics senior adult programs. Clearly the pool's closing, which contributes so much to overall public health and physical resilience, affected people's ability, while no longer fearful due to Covid, to more fully participate in exercise.

If an award is made, describe how Albany County stakeholders will benefit. Where possible, please use measurable outcomes to quantify impact.

The return of the Albany JCC's indoor pool will see the resumption of year-round access to aquatics activities for many Albany County residents. Chief among them are senior adults for whom aquatics is a principal means of exercise. This was especially true in the aftermath of Covid, where swimming was perceived as a safer alternative

for exercise than land-based fitness. Senior adults who utilize the JCC through a Silver Sneakers and other insurance-based portals are particular beneficiaries of the pool. Other stakeholders include young families who desire swim lessons for their children, and adults whose membership in the JCC is more greatly valued by the pool.

The JCC and its pool are a source of lifeguard and water safety instructor (WSI) training. This certainly benefits the JCC, but also other pool locations in Albany County where these lifeguards and WSIs are employed.

The impact of the pool can be measured first in its impact on JCC membership. The JCC saw an increase in membership in 2022 from its pandemic lows. This increase was halted with the close of the pool in 2023. And the increase in 2022 was reflected in all demographics of membership, including senior adults and young families. The pool's return will also be measured in an increase overall in the number of exercise classes the JCC offers. Last, the JCC tracks participation in all programs and will be able to quantify the impact the reopening of the pool has on participation.

Please describe your organization's ability to implement the project you propose including organizational structure, staff members involved, a summary of similar initiatives you have undertaken and the date they were completed:

The JCC has a full-time, long tenured director of aquatics and a full-time facilities director of facilities who will oversee the project. It engaged an engineering form with particular expertise in pool construction to do the initial assessment of the pool, and then was engaged to develop and design the reconstruction project, put together the bid documents, help with the identification and the selection of the construction company, and help oversee the work. The JCC's CEO has been principally involved with raising the necessary funds for the project, contracts review were part of the board of director's approval process to move forward, and the JCC has the necessary insurance coverage for such projects.

In 2020, the JCC successfully competed a small project to replace the supply piping to the pool from the pump room. And more recently, the JCC successfully completed projects for grant-funded projects of an outdoor ropes course (2021) and two outdoor "yurt" projects (2023).

How will you track performance goals and define success? Include at least two key performance indicators and expected annual outcomes/impact?

A first milestone of progress will first be measured by a successful completion of the renovation in the approved and contracted time period of March/April 2024. A second will be the return of JCC members who "froze" their membership when the pool was closed. A third will be the JCC's meeting its 2024 Aquatics Department budget, which set revenue goals of \$127,000 for operating for eight months of the year.

Other Funds: \$400,000. State sources include \$350,000 in two grants from state elected officials in support of the project and \$50,000 in the competitive CFA REDC process. This funding will be used for the majority of the initial \$516,000 approved contractual fee for the pool reconstruction project.

ARPA funding is needed to complete the funding required for the initial \$516,000 approved contractual fee for the pool reconstruction project. Additional monies are needed for anticipated enlarged scope of tilework the project is likely to require and is funding dependent. Finally, ARPA funding is requested for a second stage of the pool project that begins with the replacement of the pool filter which is not within the scope of the current contract and estimated at \$80,000. Should funding be less than requested, the scope of additional tilework and pool filter work would be reduced or deferred.

ARPA funds must be expended by December 31, 2026. Please describe how your project will be sustained if it will continue beyond this date.

By contract, the project must be completed prior to April 1, 2024. As the funding request is for construction, no operating costs are being requested for funding.
