Justification: (state briefly why legislative action is requested)

In April, 2017, New York Governor Andrew M. Cuomo signed legislation raising the age of criminal responsibility to 18-years-old in an effort to provide young people in New York with the intervention and evidence-based treatment they need. The new measures was phased in over time, raising the age of criminal responsibility from age 16 to 17-years-old beginning on October 1, 2018, and subsequently raising the age to 18-years-old on October 1, 2019. The Probation Department would like to enter into a contract with Northern Rivers to provide Raise the Age Services. The program will be designed to provide enhanced case management services to Raise the Age population, while incorporating the use of parent advocates and community coaches/credible messengers. These individuals will be members of the community with real life experiences that will be helpful in assisting youth and families navigate the juvenile justice system, all of which will be under the supervision and guidance of a case manager. Service will include mentoring, transportation, skill building, parental support/education, housing assistance and vocational/educational advocacy. Northern Rivers will work closely with the Probation Department responding to each youth's individual needs.
