The Department of Mental Health requests permission to enter into a contract in 2022 with Rehabilitation Support Services (RSS) for the provision of supported housing, outreach, transportation, PROS and MICA homeless services to Albany County citizens suffering from mental illness. NYS Office of Mental Health (OMH) will provide pass through funding to RSS through Albany County Department of Mental Health in the amount of \$3,877,435. This appropriation is anticipated in the 2022 budget. There is no County share associated with this contract.
