Project Information

Please provide a short summary of your proposed project including a project name, general description, total cost, reason(s) why you are pursuing the project and anticipated impact:

The New York State Department of Labor projects a 43.5% growth in healthcare support job openings in the Albany County area between 2018 and 2028. Capital Region BOCES Health Science Program will train adults in the skills they need to fill these high-demand positions as Certified Nursing Assistants, Home Health Aides, Personal Care Assistants, Sterile Processing Technicians, and Licensed Practicing Nurses. However, many potential students face obstacles to program enrollment and completion. The Removing Barriers to Success project will provide 60 low-income adults with financial assistance to complete a healthcare training program. BOCES' adult education programming routinely serves many students who fall into one or more of the following categories: low-income; those with no high school diploma; people with disabilities; veterans; English language learners; and those who have aged out of the school system but need job training. Because of their personal financial constraints, many potential students are unable to enroll in the program because they cannot afford the tuition and fees. They are forced to continue to work low-paying jobs, depriving their families of financial stability and progress. Of the students who do enroll, many need to leave the program before completion due to unexpected financial obstacles like loss of a job or a car needing repair.

Capital Region BOCES requests \$433,600 in ARPA funds to provide 60 Albany County residents with financial support, including full tuition, to complete a course of study leading to certification and employment as Certified Nursing Assistants, Home Health Aides, Personal Care Assistants, Sterile Processing Technicians, and Licensed Practicing Nurses. Removing the financial barrier will allow 60 low-income adults to pursue training and certification that will lead to higher-paying, in-demand positions they would not otherwise have access to. The impact of this project is twofold: (1) The students who complete the program will be gainfully employed in a fulfilling job leading to a higher quality of life for themselves and their families and (2) these 60 adults will meet the demand for these positions in hospitals, nursing homes, and other healthcare facilities in Albany County, directly impacting the healthcare thousands of county residents receive.

According to the U.S. Census, 12% of Albany County residents live below the federal poverty line. Many applicants for Capital Region BOCES' Health Science Program fall into this category. ARPA funding will remove the financial barriers for 60 Albany County residents who may otherwise not be able to afford the tuition. Eligible applicants who

demonstrate both financial hardship and the ability to persevere through the training will be provided with tuition for the Certified Nursing Assistant (CNA)/Home Health Aide (HHA)/Personal Care Assistant (PCA) program, the Sterile Processing Technician (SPT) program, and the Licensed Practicing Nurse (LPN) program through Capital Region BOCES.

All applicants to the Health Science Program complete a Free Application for Federal Student Aid (FAFSA), where they disclose their income. Students whose income is under 350 percent of the Federal Poverty Level will be considered for this funding. These students must pass the Test of Essential Academic Skills (TEAS) and interview for the program to verify that they have the academic and personal fortitude to be successful. The full cost of tuition will be provided for 60 students across three programs. 20 students in the LPN program will receive tuition assistance after Pell funding has been applied. A total of 20 students in the CNA/HHA/PCA program and 20 students in the SPT program will receive full tuition funding and will also be provided funding for academic supplies and certification test fees.

All students must meet academic and attendance standards, and complete required classwork and clinical hours to acquire certification. When students have completed all coursework and passed their certification exams, they will be ready to seek employment in these in-demand fields.

Each program has different licensing requirements regarding classwork and clinical hours. Students in the CNA program must complete 144 hours of classwork and clinical experience; the HHA program requires 54 hours; and the PCA program requires 56 hours. Students may complete any combination of these three programs to attain multiple certifications.

Students must complete 400 hours of coursework and clinical practice to obtain SPT certification. This program runs from November to May. The LPN course requires 1,100 hours of study, including clinical work. Students in this program have the option of attending full-time for 10 months (September to June) or part-time for 18 months (January to June). If notification of award is received by September 1, students who enroll in the Fall 2023 semester will begin to receive funding.

Because of the ongoing nature of the Health Science Program, the 60 students who receive funding will be in different cohorts.

Students in the Health Science Program come from all over Albany County. To fulfill requirements and become certified, students must attend classes at the Capital Region BOCES Career & Technical Education Center located on 925B Watervliet-Shaker Road, Albany and clinical practice sessions at healthcare facilities throughout the region. For many current and prospective students, reliable transportation between these locations and home is a barrier to entering or completing a course of study. Many students rely on Uber, which is unsustainable for people with low incomes. To ensure students meet minimum attendance requirements and clinical practice hours, Capital Region BOCES will provide Tech valley Shuttle and/or CDTA transportation to all students who qualify for this program. CDTA STAR Tripbooks, Pay As You Go cards and/or similar transportation vouchers from Tech Valley Shuttle will be purchased and supplied to students who do not have transportation or who lose access to a vehicle while enrolled in the program.

Describe your organizations experience as a provider of workforce development/ training opportunities, including any experience in Albany County.

Since 1953, Capital Region BOCES has led the region in training thousands of students of all ages across a variety of sectors. This includes operating Albany County's largest healthcare training program for adults, many of whom represent disadvantaged populations, including single parents, low-income individuals, individuals with disabilities, and English language learners. In partnership with local healthcare providers, the health sciences program prepares students for in-demand careers as practical nurses, home health aides, personal care assistants, certified nursing assistants, and sterile processing technicians.

The increased demand for workforce development opportunities led Capital Region BOCES to open a new, state-ofthe-art Career & Technical Education (CTE) Center in September 2022. This facility is home to 25 high school programs and several adult education programs that prepare students for in-demand careers, including those in the health science areas. This new facility is designed to accommodate today's programs and evolve to accommodate training for future in-demand careers. An integral part of all programs is work-based learning opportunities. The Capital Region BOCES CTE program has advisory boards comprised of local employers who provide guidance to ensure programs are meeting the needs of employers. In addition, the teaching staff are credentialed experts in their field and bring years of work-based experience to the program.

The COVID-19 pandemic impacted the number of students who entered and graduated from the healthcare support training programs. Despite this, as of 2022, the placement rate for graduates of the three-year-old Sterile Processing

Technician program is 100%. Enrollment in the Licensed Practical Nursing program increased by 22% in school year 2022-2023, approaching pre-pandemic levels.

Capital Region BOCES provides students in the Health Science Program with access to hands-on training in various clinical settings in Albany County. This clinical experience fulfills the required hours students must complete to be certified as Licensed Practical Nurses (LPNs), Home Health Aides (HHAs), Certified Nurse Assistants (CNAs), Personal Care Assistants (PCAs), or Sterile Processing Technicians (SPTs). Often, these training experiences result in full-time employment for students upon program completion. Clinical training partners for this grant include Albany Medical Center, St. Peter's Hospital/St. Peter's Health Partners, Daughters of Sarah, Our Lady of Mercy Life Center, Shaker Place Rehabilitation and Nursing, and Teresian House. These partners will receive no funding through implementation of this project.

ARPA funding for the Capital Region BOCES Health Science Program will benefit the residents of Albany County in two ways: increased employability for 60 unemployed or underemployed adults and increased access to healthcare support professionals. The COVID-19 pandemic put a strain on the healthcare system, resulting in healthcare professionals leaving their positions and the healthcare support field. A report by the Duquesne University School of Nursing forecasts a shortage of more than 400,000 home health aides and 29,400 nurse practitioners by 2025, as the population continues to age. ARPA funding will provide 60 Albany County residents with financial assistance to become trained and certified healthcare support workers:

- 20 adult residents will enroll in and complete the LPN job training program at CR BOCES;

- 20 adult residents will enroll in and complete the SPT job training program at CR BOCES;

- 20 adults will enroll in and complete the CNA/HHA/PCA job training program at CR BOCES;
- 60 adults in these programs will receive access to transportation to support their enrollment.

Although we are projecting a balanced enrollment across programs, Capital Region BOCES reserves the right to adjust enrollment to support the 60 eligible students based on program demand (e.g.: 15 SPT and 25 CNA/HHA/PCA etc.)

In order to be eligible for ARPA funding, programs must serve low-to-moderate income households/communities (classified as 350% of the Federal Poverty Level) or households that experienced unemployment during the COVID-19 pandemic. Please describe specifically how your proposal will benefit unemployed or underemployed individualsmeet this requirement and how you will verify this to the County.

Most applicants to the Health Science Program currently meet the threshold of 350% of the Federal Poverty Level. This is verified during the application process where prospective students fill out a Free Application for Federal Student Aid (FAFSA), disclosing their income and wealth. As part of Capital Region BOCES' policies, the program's financial aid examiner will consult with Albany Career Central to ensure that recipients of ARPA funds meet the funding income requirements. The financial aid examiner maintains all records of student income status, determining who qualifies for financial aid or ARPA funding.

How Will You Track Performance Goals And Define Success? Include at least two Key Performance Indicators and expected annual outcomes/impact during the reporting period (September 2023 - December 2026).

Capital Region BOCES will track student enrollment and employment after graduation to define success during the reporting period. Utilizing the current application review process, program staff will identify eligible candidates to receive ARPA funding.

Performance Indicator - 20 students in the LPN program will receive free tuition based on financial need. Outcome - The 20 students who receive financial assistance will complete the LPN program.

Performance Indicator- 20 students in the CNA/HHA/PCA program will receive free tuition, books, and uniforms based on financial need.

Outcome - The 20 students who receive financial assistance will complete the CNA/HHA/PCA program.

Performance Indicator- 20 students in the SPT program will receive free tuition and books based on financial need. Outcome - The 20 students who receive financial assistance will complete the SPT program.

Performance Indicator - Students who receive ARPA funding will have a 90% employment rate within six months of program completion.

Outcome - Students who receive ARPA funding will be gainfully employed in in-demand healthcare positions.

Capital Region BOCES will continue to offer health careers training to Albany County residents after ARPA funds have been exhausted. The healthcare support field, which includes Licensed Practical Nurses (LPN), Home Health Aides (HHA), Certified Nurse Assistants (CNA), Personal Care Assistants (PCA), and Sterile Processing Technicians (SPT), is expected to continue to grow as the population ages. Capital Region BOCES has a successful record of securing NYS Department of Labor funding for its workforce training programs and will continue to pursue grant opportunities to sustain its workforce development initiative, as well as form and maintain partnerships with organizations in the healthcare field.

Applicants to the Health Science Program face personal and financial obstacles to enrollment and completion. Capital Region BOCES' adult education programming routinely serves many students who are low-income, do not have a high school diploma, have disabilities, or are English language learners. Many are working low-income jobs and are looking for training to qualify for skilled positions in the workforce. Because of their personal financial constraints, many potential students are unable to enroll in the program. This program will serve the healthcare industry, which needs qualified candidates in several positions. According to the University of Albany School of Public Health, nursing homes report that CNAs and LPNs are difficult to recruit and retain, while home healthcare agencies struggle to recruit and retain HHAs and PCAs. The New York State Department of Labor projects a 43.5% increase in healthcare employment in the Capital Region through 2028 as the area's population continues to age. The students who complete the Health Science Program through Capital Region BOCES will fill this employment gap, addressing the healthcare needs of Albany County residents. Students who complete the program are highly trained, completing their clinical experience hours with the organizations that often offer Capital Region BOCES students employment upon graduation. Capital Region BOCES will partner with Albany Medical Center, St. Peter's Hospital/St. Peter's Health Partners, Daughters of Sarah, Our Lady of Mercy Life Center, Shaker Place Rehabilitation and Nursing, and Teresian House.
