<u>Justification</u>: (state briefly why legislative action is requested)

The Public Defender's Office requests authorization of the Fourth Counsel at First Appearance (CAFA 4) grant contract with the NYS Office of Indigent Legal Services. The grant provides resources needed to provide legal representation at arraignment 24/7 for any indigent individuals arrested. CAFA 4 will allow the County to continue to provide services that were previously provided by CAFA 1, CAFA 2, and CAFA 3. Spending under CAFA 4 will not begin until calendar year 2025 because there was a two-year delay in CAFA implementation at its onset.
