<u>DESCRIPTION OF REQUEST:</u> (state briefly why legislative action is requested)

The Department for Aging (DFA) requests legislative approval to enter into a renewal contract with Peter Young Industries, to provide Home Delivered Meals to seniors who reside within Albany County and meet specific criteria as required by Albany County, NYSOFA, and the Albany County Central Assessment Unit. Peter Young Industries will provide Home Delivered Meals to seniors within the following zones; Colonie, Arbor Hill, and Guilderland. The number of meals contracted in this zone area for 2026: 44,448

The meal delivery shall include regular client monitoring, along with informing the community about the Home Delivered Meal program through education handouts and presentations. Peter Young Industries shall be responsible for ensuring meals meet nutritional requirements established by the Food and Nutrition Board of the National Academy of Sciences National Research Council.
