# **DESCRIPTION OF REQUEST:** (state briefly why legislative action is requested)

The Department of Mental Health requests permission to enter into a contract in 2026 with Second Chance Opportunities for the provision of treatment services to Albany County citizens with substance abuse and narcotic addiction related issues. Second Chance Opportunities is a not-for-profit corporation dedicated to providing supportive services to people in recovery from substance use disorder. NYS Office of Addiction Services and Supports (OASAS) will provide pass through funding to Second Chance Opportunities through Albany County Department of Mental Health for \$568,575. This appropriation is anticipated in the 2026 budget. There is no County share associated with this contract.
