**DESCRIPTION OF REQUEST:** (state briefly why legislative action is requested)

The Department of Mental Health requests permission to enter into a contract in 2026 with Albany County Department for Children, Youth and Families (DCYF) for the provision of clinic, health home and Single Point of Access (SPOA) services to Albany County children and their families suffering from mental illness. NYS Office of Mental Health (OMH) shall provide pass through funding to DCYF through Albany County Department of Mental Health for \$416,301. This appropriation is anticipated in the 2026 budget. There is no County share associated with this contract.
