As part of the larger negotiation of the 2023-2027 Collective Bargaining Agreement, the New York State United Teacher's Union has negotiated a new rate structure for Registered Nurse (RN) Supervisors with Shaker Place that go into effect in 2022. The new rate structure for the RN Supervisors is requested earlier than 1/1/2023 in an effort to more quickly meet the NYSDOH 3.5 hours of care per day Legislative mandate and the new CMS staffing requirements for their Five Star Rating system.
