After a thorough "request for proposals" process was undertaken, Trinity Alliance was selected by members of the Albany LEAD Policy Coordinating Group (PCG) to operate as the new host agency for LEAD project management, and be the employer of record for project managers in the City of Albany and other locations within Albany County. Additionally, Trinity Alliance, will serve as the employer of record and manager for the community outreach and engagement functions of LEAD, working collaboratively in the City of Albany with the Albany LEAD Policy Coordinating Group (PCG), project managers, community-based organizations and community members to coordinate and ensure diverse community outreach and engagement. The FY2022 COSSAP subaward to Trinity Alliance is for \$167,480; the FY2020

COSSAP subaward to Trinity Alliance represents the balance of the subaward made to the Public Defender Association (who will no longer be the employer of record for Albany LEAD project managers) pursuant to resolution 21-158. Additionally, resolution 22-540 is being amended to increase the subawards under the FY2022 COSSAP to Catholic Charities Care Coordination Services (which performs case management for LEAD clients) in the new amount of \$462,251; and SUNY at Albany (which will be conducting an evaluation of the program) in the new amount of \$246,396.
