The county sponsored an application for a snowmobile trails maintenance grant and was awarded funding through NYS Department of Parks, Recreation and Historic Preservation to assist local snowmobile clubs with the development and maintenance of snowmobile trails in the county. The total amount of the award is \$14,955. The funds will be passed through to Frontier Sno Riders and Middleburgh Ridgerunners, the organizations responsible for maintenance.
