Due to a an error by NYS Parks, Recreation and Historic Preservation in calculating eligible trail mileage for Frontier Sno Riders, the total grant award and reimbursement amount for Frontier Sno Riders was incorrect. At the time of the grant closeout, the error was identified and it was determined that the club is eligible for an additional \$336. This is a pass through grant.
