Thank you for participating in the Municipal Electric and Gas Alliance (MEGA) energy procurement program.

As you may know, MEGA's procurement for electric and natural gas supplies, and renewable energy credits, was conducted through Genesee County in conformance with New York State General Municipal Law and County Law. The Invitation to Bid was issued on August 23, 2018, and bids were received on September 7, 2018. As MEGA has in the past, we have recommended the lowest qualified bidder be awarded the contracts by Genesee County. Our partner in this procurement, Genesee County, was in conformance with the "piggybacking" provisions of Section 408-a of the NYS County Law and Section 103(3) of the NYS General Municipal Law, allowing all political subdivisions and districts within the State of New York to participate in the contracts awarded as a result of this procurement.

MEGA has endorsed **Direct Energy** for as the preferred vendor for natural gas supply programs in the National Grid, New York State Electric & Gas, Rochester Gas & Electric, National Fuel Gas utility territories through October 31, 2023.

MEGA is aware of the recent completion of the acquisition of Direct Energy by NRG Energy.
