DESCRIPTION OF REQUEST: (state briefly why legislative action is requested)

The County Executive's Office respectfully requests that the Albany County Legislature authorize a contract extension between Albany County and BusPatrol America LLC for Stop Arm Camera Services in Albany County. This extension continues our current contract outline with BusPatrol, while changing the revenue split starting with the third year of the term from 60% BusPatrol-40% Albany County to 55% BusPatrol-45% Albany County, adding a clause that requires the approval of a business rules questionnaires, and adding a clause to allow for alignment on the collection of outstanding citations.
