Dear Chairman Joyce:

Legislative approval has been granted to allow for purchases totaling more than \$100,000.00 and to make budget line changes.

Albany County has entered into a grant contract with the State of New York, Division of Homeland Security and Emergency Services for the 2020 Statewide Interoperable Communications Grant.

The aforesaid contract was awarded in the amount of \$1,200,054.00.

Resolution #33 of 2022 authorized an over \$100,000.00 expenditure of \$315,635.00 for the purchase of two generators from Better Power, Inc., of Rochester, N.Y. This pricing was based on a price quote provided on August 26, 2021, which was valid for 60 days.

Due to pricing increases over the last six months the quote has increased to \$334,691.10 a difference of \$19,056.10.

Based on the pricing increase we are requesting an amendment to Resolution #33 of 2022, by changing the authorized expenditure to Better Power Inc. for the amount of \$334,691.10, reimbursable through grant funding.

There are no matching funds required.

The grant performance period is 01/01/21 through 12/31/22.

This grant contract was authorized under resolutions 21-435.

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter into an agreement with Motorola Solutions, Inc., Woodcliff Lake, NJ 07677 for the annual maintenance and licensing fees for radio equipment at the new E-911 Dispatch Center in an amount not to exceed \$476,610, and, be it further

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter into an agreement with Better Power, Inc., Rochester, NY 14624 for the purchase of two generators for the new E-911 Dispatch Center in an amount not to exceed \$315,637, and, be it further




