The attached correspondence is forwarded for presentation to the Albany County Legislature.

Legislative approval is required to upgrade our core E911 System. Recent events have made this a necessary expenditure as it will also upgrade the Computer Aided Dispatch, Mobile Data, Field Operations and Records Management Systems. These upgrades will enhance the public safety tools that are being used in the Capital District.

Central Square's public safety solution will provide three (3) things. First, it will provide a greater degree of redundancy as we will be able to partner with other counties to co-locate critical system resources. Second, it will allow agencies a higher degree of flexibility when configuring their agency's functional needs. Third, it will provide a platform to leverage other participating agencies resources for overall system health.
