The Department of Mental Health requests permission to enter into a contract in 2024 with Equinox for the provision of supported housing, health home, advocacy and service dollar management services to Albany County citizens suffering from mental illness. NYS Office of Mental Health (OMH) will provide pass through funding to Equinox through Albany County Department of Mental Health for \$947,789. This appropriation is anticipated in the 2024 budget.
