Date of Adoption:

The Public Defender's Office requests authorization to accept the Third Upstate Quality Improvement and Caseload Reduction grant from the NYS Office of Indigent Legal Services. The grant award is intended to allow Albany County to continue the programs currently funded by the 2nd Upstate grant contract, for which funding was exhausted in 2021. The Third Upstate Quality Improvement grant has a 3 year term from June 2020 through June 2023. However the Public Defender's Office was not able to spend down this grant until the Second Upstate Quality Improvement grant was expended, which is why the start date is delayed. This grant is in the amount of \$300,000, approximately \$100,000 annually and provides salary support to Public Defender Office staff. This was anticipated in the 2022 County budget.
