<u>Justification</u>: (state briefly why legislative action is requested)

The Albany County Department of Health (ACDOH) is requesting approval of an agreement with the Civil Service Employees Association, Inc., Local 1000, AFSCME, AFL-CIO, Albany County Local 801 (the "Bargaining Unit") on terms and conditions of employment for the period January 1, 2023 through December 31, 2027. Under the terms of the agreement, employees of the bargaining unit will receive an increase of \$1,000 to base salaries, retroactive to January 1, 2023. The 2023 ACDOH budget anticipated the increased salaries and will fund these with the Enhanced Pay line.

As a result of these terms and conditions, we are amending salary lines in the 2023 budget to account for the \$1,000 increase to base salaries.
