The Office of the Public Defender is requesting an amendment to its 2022 Budget. Due to unanticipated expenditures, recent reclassifications of how the Public Defender's Office is categorizing expenses, and other administrative adjustments, the Legislature's authorization is needed to amend the 2022 Budget in order to transfer \$30,000 into the Books/Transcripts/Subscripts line from Fees for Services.
