**DESCRIPTION OF REQUEST:** (state briefly why legislative action is requested)

The request is to modify the 2025 budget to accept an additional \$8,592 in grant funding. In February 2022, CVSVC was awarded funds from the Family Violence Prevention and Services Act (FVPSA) American Rescue Plan (ARP) Rape Crisis and Sexual Assault Programs Supplemental COVID-19 Grant. The original Grant Period/Term was October 1, 2021 - September 30, 2024, and the original total amount was \$194,670. We have just been notified that they have revised the Grant Period/Term to October 1, 2021 - June 30, 2025, with a revised total award amount of \$203,262. We respectfully ask for approval to accept the additional \$8,592 in grant funding. While \$2,592 will be added to the Fees for Services line, the remaining \$6,000 we are receiving will offset a portion of Special Programs expenses and the Deputy Director salary that were already budgeted for 2025.
