The Mental Health Department requests permission to accept a non-competitive, formula-based workforce enhancement grant in the amount of \$100,000 from NYS Office of Mental Health (OMH). The Workforce Grant award from NYS Office of Mental Health (OMH) provides funding to eligible providers proportionally based on reported FTEs in eligible programs. Eligible uses include: recruitment & retention incentives (i.e hazard pay, shift differential, longevity bonuses, vaccination incentive, signon bonuses, etc.); educational reimbursement (i.e. tuition, exams, application fees, etc.); and career development and training. The grant covers a period from 1/1/2022 through 12/31/2022, and will be included in the Department of Mental Health's 2022 budget. There is no County match.
