Pursuant to RFB-2023-144 the Department of General Services requests Legislative approval of a contract with CKM Electrical Services, Inc. as the lowest qualified bidder with a base bid of \$415,500.00 and a 10% contingency of \$41,550.00 for a not to exceed cost of \$457,050.00.

Under this contract CKM Electrical Services, Inc. will provide and install the specified emergency generator and upgraded switchboard. The emergency generator will help to ensure the departments of Mental Health, Children's Advocacy Center and Board of Elections are able to continue functioning in the event of a power outage.

The cost of this project are included in the A Fund 2023-2027 Capital Plan - DGS-23-01 and will be covered utilizing bond HHXO pursuant to Resolution 10 of 2023 adopted February 13, 2023.

The Projected term of the contract is April 1, 2024 through March 31, 2026
