Slingerlands Fire Departments- 1992 to Present

I have been chief of the department since January 1, 2019, working my way through the ranks as Fire Fighter, Lieutenant, Captain, and Assistant Chief. I have also served as the Department President. Within the role of Chief, I am accountable to the Board of Fire Commissioner and am responsible for over \$150,000.00 in budgeted monies. The district has a comprehensive Procurement and Investment Policy that I am required to follow. There are 35 plus members of the department as well as 2 Engine/tankers, 1 Rescue Truck, 1 Brush truck, a Fire Police Vehicle, and multiple other trailers and a UTV. In addition to the members and the apparatus I am responsible for all our equipment. We are aggressive with the annual testing of all equipment and gear. Our members are required to have an annual physical and fit test, this can often lead to reclassification of fire fighters. Under my leadership we have built strong relationships with our surrounding departments during mutual aid calls, as well as training with them. Always trying to better each department in firefighting and rescue skills.

First Responder Lawn Care and Plowing- 2021 to Present

Handling multiple accounts to provide lawn care as well as plowing service. Working with residents of the county, specifically the elderly, to make sure that they are getting a fair price for lawn care work and plowing.
