Enterprise Rent-A-Car has requested an approval to renew/extend their lease for an additional five-year term beyond the current agreement expiration date, which is January 31, 2022. Enterprise has paid their lease payments and expenses on time and they are a good tenant. They have asked to include an Exhibit D to the lease which will formalize what has been a part of the agreement from the beginning, whereby they are entitled to use space in the MVP Arena parking garage to prep and clean their cars. A mutually acceptable area has been identified within the garage near the fence gate area that will permit cleaning of cars to occur with no infringement on parkers or pedestrians going through the garage. Enterprise needs this area, which they have used since starting the lease several years ago.
