### **DESCRIPTION OF REQUEST:** (state briefly why legislative action is requested)

The Department of Public Works is requesting the Legislature's approval of the attached agreement between Albany County and the New York State Department of Transportation (NYSDOT) regarding Design, ROW Incidentals and Acquisition and Construction/CI work for replacement of the County Route 301 (Tarrytown Road) culvert over Onesquethaw Creek in the Town of New Scotland. This project was awarded \$1,500,000.00 in funding through the 2023 Culvert NY program; as such, the project costs will be State funded up to \$1,500,000.00. If the project cost should come in over \$1,500,000.00, the additional amount would need to be covered by the County.
