Retail leases require legislative approval. This is a new tenant who will replace the previous occupants known as Ballistic Shrimp. \$17 per square foot for rent and \$2 per square foot for common area maintenance fees (total \$19 per square foot) X 950 square feet of space = \$18,049.92 annually for each of the three-year lease. Monthly payments will be \$1504.16 starting December 1, 2023, and ending on November 30, 2026. In addition, a mutual option to renew the lease for another three-year term will be included in the lease.
