**DESCRIPTION OF REQUEST:** (state briefly why legislative action is requested)

We request the Legislature's approval of an agreement with Highway Rehab. Corp. for Hot-in-Place Asphalt Recycling along 5.96 miles of CR408 in the Town of Westerlo. The Hot in Place Recycling (HIP) process rehabilitates and restores deteriorated asphalt pavement, minimizing the use of new materials. The roads chosen for this treatment are beyond milling and repaving, but are not in need of full depth replacement. Highway Rehab. Corp is on New York State Contract Group 31555 Award 23334. I recommend Highway Rehab. Corp. as offering the best value for Albany County with project total of \$462,391.29. This work will be paid for out of the County's Highway Recycling Capital Plan.
