**Justification**: (state briefly why legislative action is requested)

The Office of the Albany County District Attorney seeks to balance a negative budget line for Overtime (19900) in the amount of \$28,708.27. We are looking to correct that overage by moving \$12,500 from Temporary Help (19970) and \$30,000 from the Discovery Grant Overtime line (19900D) to the Overtime line (19900). This totals \$42,500 and should cover overtime expenses through the end of the year.

We are also looking to address a negative budget line for Travel Mileage and Freight (44038) in the amount of \$13,009.73. We are looking to correct that overage by moving \$16,000 from Temporary Help (19970) and \$13,500 from the Computer Equipment line (22050) to Travel, Mileage and Freight. This totals \$29,500 and should cover expenses through the end of the year.

Finally, we are looking to address a low balance on our Fees for Services line (44046) which is currently at \$16,597.52. Taking into account expenses we expect to incur over the next two months, we are asking to move \$10,000 from Office Supplies (44020) and \$35,000 from the Clerk of the Works line (17107) to the Fees for Services line. This totals \$45,000 and should cover expenses through the end of the year.
