## **DESCRIPTION OF REQUEST:** (state briefly why legislative action is requested)

The Town of Coeymans Assessor, Ms. Dawn DeRose has submitted four Applications for a Corrected Tax Roll on behalf of the owners of CR 101, Town of Coeymans, Tax Map # 143.-2-19.1/1.

Due to a Clerical Error defined by NYS RPTL § 550 (2)(a) the assessed value of the property was incorrectly entered on the 2024 assessment roll. Ms. DeRose's records contained the correct assessed value for this property is \$4,156,072.

Real Property Tax Law §554 allows for the correction of Clerical Errors made on the assessment and tax roll. I recommend that the Albany County Legislature approve the correction to the tax rolls and approve that a corrected bill be issued in the amount of \$7,285.00.
