Thank you for your inquiry. We have consulted with your GMO/GMS and we will be sending out an email addressing No-Cost Extensions (NCE) to all recipients next week. However, to answer your question right now.

NCE requests will be reviewed and considered on a case-by-case basis. The determination will be based on the justification/need and is not guaranteed. All requests must be submitted in GrantSolutions as a <u>Prior</u> <u>Approval</u> and will be reviewed by your assigned Grants Management Officer and Specialist.

As a reminder, an NCE allows a recipient to extend the project period end date and budget period for a limited time to complete award activities detailed in the approved work plan. NCE requests will not be approved for the sole purpose of using unobligated balances.

As the requesting recipient, you must establish in the justification that there is a bona fide need. The following must be addressed in the justification:

- The grant activities, goals, and objectives in their approved project proposal that have not been completed during the original project period and why.
- There is a reasonable expectation that extending the project period will lead to project completion.
- Clarify that additional funding is not required to complete the unmet project goals.
