1199 SEIU and Shaker Place has negotiated a revised salary structure for the Maintenance and Service Workers through the MOU process that will conclude 12/31/2023. This MOU will permit nursing personnel to increase their paid hours of work to 40 hours per week, with an additional ½ hour for lunch break. This revision is being implemented through an MOU and will assist Shaker Place in complying with the revised NYSDOH 3.5 hour of care per day for each resident Legislation and the new CMS Five Star Rating system. We will also be adjusting the work week of virtually every title in the CBA to 42.50 so that we can provide a hand off of care and at the same time compensate staff for this additional work.
