Hi everyone,

As you are aware, Bernadette and I are working to respond to the CDC's Notice of Funding Opportunity (NOFO) for the RPE Program for the next 5 year funding cycle (2/1/24-1/31/29). The NOFO was release on September 27th, however the CDC just provided us with our final budget today. With this information, we are offering Regional Centers the opportunity to accept an additional (up to) \$7,500/county in the region for health equity related activities. If accepted, these funds will be added to the 9-month contract budget (2/1/24-10/31/24) which was submitted in July. If you accept the funds, I will add the following to statement to the budget document: "TBD – Health Equity Activity Funds." A budget modification will be required at the beginning of the grant year (2/1/23) to utilize these funds.

Please note – This email was sent only to the lead agency staff and Regional Coordinators. Please connect with your partner agencies to determine interest.

To accept these funds you must respond by close of business on Friday, October 20th with the following information:

 - funding to be split by county and allocated to corresponding lead agency (MISC tab) AND subrecipient (SUBCONTRACTOR tab) budgets by county
