## **DESCRIPTION OF REQUEST:** (state briefly why legislative action is requested)

The Public Defender's Office, Alternate Public Defender's Office, and Assigned Counsel Program request authorization of the Second Statewide Expansion of Hurrell-Harring grant contract with the New York State Office of Indigent Legal Services, with a term of April 1, 2024 through March 31, 2027. This grant provides \$29,538,230 in funding for personnel and other expenses to continue work being done under the first Statewide Expansion of Hurrell-Harring grant that commenced April 1, 2018.

The Alternate Public Defender's Office also requests to amend its 2024 budget to reflect changes made during finalization of the grant.
