The purpose of this budget amendment is to transfer funds to the Miscellaneous Contractual line from personnel related lines so that four members of the Stormwater Coalition (Village of Menands, Town of New Scotland, City of Cohoes, and City of Watervliet) can be reimbursed for 2021 dues paid into the Coalition for which they did not receive services.

These services would have been provided by a part time Coalition Stormwater Program Technician, however that individual wasn't hired until August 27, 2021. The amount to be reimbursed represents personnel costs (base salary, social security, and retirement expenses) for pay periods prior to August 27, 2021.

The proposed dollar amount and related budget amendment was approved by the Coalition Board of Directors at their September 17, 2021 meeting.
