<u>DESCRIPTION OF REQUEST:</u> (state briefly why legislative action is requested)

The Department of Mental Health requests permission to enter into a contract in 2025 with St. Peter's Hospital/St. Peter's Addiction Recovery Center (SPARC) for the provision of community residential and case management services to Albany County citizens with substance abuse and narcotic addiction related issues. NYS Office of Addiction Services and Supports (OASAS) will provide pass through funding to St. Peter's/SPARC through Albany County Department of Mental Health for \$388,366. This appropriation is anticipated in the 2025 budget. There is no County share associated with this contract.
