## Dear Chairman Joyce:

The Department of Public Works is requesting the Legislature's approval to enter into an agreement with Callanan Industries, Inc., for our annual hauling and placing contract. 25 miles of County roadways will be paved with warm mix asphalt this year. The roadways included in the contract are:

- -CR152 from NY 155 to CR 154 (Town of Colonie) 3 miles
- -CR203 from SR155 to SR20 (Town of Guilderland) 4 miles
- -CR312 from SR443 to SR143 (Town of New Scotland) 6 miles
- -CR409 from CR405 to Greene County Line (Town of Westerlo) 2 miles
- -CR411 from Gregory Hill Rd. to Greene County Line (Town of Westerlo) 1 mile
- -CR252 from SR156 to Schoharie County Line (Town of Knox) 6 miles
- -CR411 from SR32 to Gregory Hill Rd. (Town of Westerlo) 3 miles

Callanan Industries, Inc. was the low bidder for the project, with a total project cost of \$3,883,893.09. There is currently \$2,500,000.00 in our Bridge and Road materials line (D95112 44075 10000). This line will be augmented in the coming months when we receive our annual Consolidated Local Street and Highway Improvements Program (CHIPS) award letter. We are awarding an adjusted base contract of \$2,500,000.00, with the intent of awarding the remaining \$1,383,893.09 of paving work once the 2023/2024 CHIPS money is accepted into our budget.

This contract is 100% State funded with Consolidated Local Street and Highway Improvements Program (CHIPS) funds. The County Purchasing Agent received three (3) bids for this project. Callanan Industries was the low bidder in an amount not to exceed \$3,883,893.09.
