I am pleased to announce that Albany County has been awarded \$220,092 under the New York State 2021-22 Public Safety Answering Points Operations Grant Program (2021-22 PSAP Grant). This program, administered by my agency, allows for State support to counties for eligible public safety call-taking and dispatching expenses. Your participation in this program is another example of the successful partnerships we have been developing for public safety and emergency preparedness across the state.

The performance period for the 2021-22 PSAP grant will be 12 months, beginning calendar year 2022 (January 1, 2022 – December 31, 2022). Expenses that you wish to claim must occur within that period.
