The Water Purification District (District) is requesting approval of the budget amendments outlined below to correct for budget line overages.

**Overtime Transfer:**

<i>Decrease Chief Process Operator Line (G8130.1.2635)</i>	<i>\$ 64,000 (Position# 630003)</i>
<i>Decrease Labor Sub-Foreman Line (G8130.1.7009)</i>	<i>\$ 47,000 (Position# 630087)</i>
<i>Decrease Mechanic Specialist Line (G8130.1.7032)</i>	<i>\$ 24,000 (Position# 630066)</i>
<i>Increase Overtime Line (G98120.1.9900):</i>	<i>\$ 3,000</i>
<i>Increase Overtime Line (G98130.1.9900):</i>	<i>\$ 132,000</i>
<b><i>Total Overtime Transfer Amount:</i></b>	<b><i>\$ 135,000</i></b>

This budget amendment is to account for overtime overages associated with continued staff shortages. The requested transfers are not anticipated to negatively impact the District's 2025 budget.


**Specialty Equipment Transfer:**

<i>Decrease Water Budget Line (G98130.44105)</i>	<i>\$ 20,000</i>
<i>Increase Specialty Equipment Line (G98130.22300)</i>	<i>\$ 20,000</i>

This budget amendment is to allow for the purchase of a new deionized water system to replace the existing unit that had failed. The requested transfer is not anticipated to negatively impact the District's 2025 budget.
