**DESCRIPTION OF REQUEST:** (state briefly why legislative action is requested)

The Department for Mental Health is requesting legislative authorization to amend Resolution No.465 adopted on 11/10/2025. We are requesting approval to accept additional funding for Unity House of Troy, from New York State Office of Mental Health. The funding increase is for comprehensive and coordinated treatment, support and rehabilitation services to Albany County individuals with severe and persistent mental illness. New York State Office of Mental Health has advised that there is additional funding for Unity House of Troy services in the amount of \$62,465, which is 100% state funded.
